- 2. YOU MUST ACCEPT RESPONSIBILITY FOR RENTAL EQUIPMENT.** YOUR RESPONSIBILITY INCLUDES THEFT, DAMAGE OR LOSS OF EQUIPMENT IN YOUR POSSESSION. POSITIVE ID AND DEPOSIT IS REQUIRED FOR ALL RENTALS. OVERDUE EQUIPMENT WILL BE CHARGED AT THE FULL DAILY RATE FOR EACH DAY THAT IT IS LATE. CONFLUENCE KAYAKS. WILL BE THE SOLE JUDGE OF MONETARY DAMAGES TO OUR EQUIPMENT.
